ANNUAL MIDWESTERN CONFERENCE OF PARASITOLOGISTS

Annual Report to Council, American Society of Parasitologists

Washington, D.C.

The 22nd Annual Midwestern Conference of Parasitologists met on the campus of Loyola University, Chicago, Illinois, on June 12-13, 1970. Dr. Benedict J. Jaskoski was in charge of local arrangements. The 72 registrants benefited from about 20 informative scientific demonstrations on various subjects. The graduate research papers were presented at the symposium by Paul Hitcho, Notre Dame (Factors affecting the growth and development of Trichinella in vitro), Gerald Keilman, University of Kansas (Effects of dl-carnitine on the metabolism of T. lewisi), Franklin Simmons, Illinois State University (Acquired resistance of the guppy and goldfish to metacercariae of Ribeiroia marini (Faust and Hoffman, 1934), and Paul Kasdan, Loyola (Some morphological differences between a normal strain and plaomorphic strain (mutant) of Trichophyton mentagrophytes).

The 4th annual C. A. Herrick Award, sponsored by Eli Lilly and Company, was received by Harvey D. Blankespoor, Iowa State University, for excellence in demonstrating his research (Hostinduced variation of an avian trematode, Plagiorchis noblei).

The annual address was given by Dr. Martin J. Ulmer, Iowa State University, on the subject "Helminths from the Midwest to the Mediterranean", in which he gave accounts of his years of research at Iowa's biological station and of his several months of study on parasites of fishes from the Bay of Naples, Italy.

The 1971 meeting of the Conference will be held at the University of Louisville, Dr. Frederick H. Whittaker being in charge of local arrangements. The 1972 meeting was announced for Southern Illinois University, Carbondale.
